RULES & CONDITIONS:

STALLION ENROLLMENT: Costs \$1000 per stallion. Each stallion enrolled in the XL Stallion Bonus & Incentive Program will receive arena signage (4 x 8 banner) throughout the duration of any XL Enterprises produced event, namely the Silver Cup Barrel Futurity, Derby & 4D Sweepstakes, the Gold Cup Barrel Futurity & Deby and our new Diamond Classic Team Roping Horse Futurity & Jackpot. Your stallion will also receive a Stallion photo & listing on our web site www.silvergoldcup.com with link to your web site if one is available, as well as name recognition through listing on all promotional material for the XL Stallion Bonus & Incentive Program, through out 2007.

UPDATED BONUS PAYBACK!!!

STALLION BONUS: Once a stallion pays for enrollment, \$200 comes out right off the top and goes toward the Stallion Bonus (\$200 x number of stallions enrolled = Stallion Bonus purse), which will pay back in the same season the stallion is enrolled. Gold Cup XL Stallion Bonus will be paid back to stallion owners **WILL NOW BE BASED ON THE FASTEST 2-RUN AVERAGE TIMES FROM THE LONG ROUNDS AT THE GOLD CUP BARREL FUTURITY!** Sample XL Stallion Bonus Payoff:

- 1 money for 1-10 enrolled stallions (10 stallions would pay = \$2000 winner take all)
- 2 monies for 11-20 enrolled stallions (20 stallions would pay = \$4,000 with split of 60% to 1st \$2,400 and 40% to 2nd \$1,600)
- 3 monies 21-30 enrolled stallions (30 stallions would pay = \$6,000 with split of 50% to 1st \$3,000, 30% to 2nd \$1,800 and 20% to 3rd \$1,200)
- 4 monies 31-50 enrolled stallions (50 stallions would pay = \$10,000 with split of 40% to 1st \$4,000, 30% to 2nd \$3,000, 20% to 3rd \$2,000 and 10% to 4th \$1,000)

START PLANNING NOW FOR THE 2007 PROSPECT MARKET!!!

SIRE PROGENY PROSPECT MARKET: The Sire Progeny Prospect Market is open to stallion owners enrolling stallions in 2007 in the XL Stallion Bonus & Incentive Program. Each stallion owner will be invited to showcase his stallion during the the Prospect Market and will also receive three participation berths, which may be used for putting up to three (3) barrel futurity prospects (prospects to be defined as a horse under the age of 5 who has never competed in any barrel race competition for money, points or prizes) in the Sire Progeny Prospect Market. Participation berths are non-transferable and are only available to the progeny of the 2007 enrolled stallions. The 2nd annual Prospect Market will take place during the 2007 Gold Cup Barrel Futurity, which will be run June 20-24, 2007 at the Lazy E Arena in Guthrie, OK. Prospect Market packets will be sent out to stallion owners upon enrollment. Stallion owner will responsible for filling out participation forms for each horse he/she plans to bring and return it to XL Enterprises on or before the indicated deadline. Prospect Market stalls will be \$70 each and will be assigned in the order they are received. All Prospect Market stalls will be located together and identifiable by a stall card with participating horse's name, registration number, 3-generation pedigree and owner comments. The Prospect Market will be for all purposes a "Private Treaty" sale venue, with no consignment fees and no commissions. All sales will be expressly between the seller and the buyer. XL Enterprises, LLC will keep a database containing the registered names of the participating horses, the breedline, and the year in which each horse participates in the Prospect Market. Should any horse which has previously participated in the

Prospect Market, become a Gold Cup Futurity entry, XL Enterprises, LLC will wave the \$100 Incentive Fund registration fee.

SIRE PROGENY FUTURITY INCENTIVE FUND: XL Enterprises guarantees a \$10,000 minimum incentive purse in 2008. This incentive money will be available only to the eligible progeny of the stallions who were enrolled for the 2007 season. Therefore, a stallion's incentive enrollment (for any given year) will be paid back in the incentive fund the following season. Thus, giving XL Enterprises a full year to advertise the XL Stallion Bonus & Incentive Program, Stallions and Purse (minimum \$10,000) beginning in August when we start advertising for the 2007 Silver and Gold Cup Barrel Futurities. The Incentive Fund Purse will be paid back at the Gold Cup Barrel Futurity on a two run average from the two long go rounds. Number of places paid back will be determined by the total purse value. For Example: \$10,000 minimum will pay back 4 places; 1st \$4,000 / 2nd \$3,000 / 3rd \$2,000 / 4th \$1,000.

INCENTIVE FUND PROGENY ELIGIBILITY: A \$100 registration fee will be required, in addition to any regular designated Futurity entry fees. (Exception: The \$100 registration fee will be waved, by XL Enterprises, LLC, for any horse which previously participated in the Sire Progeny Prospect Market). Only futurity eligible horses sired by stallions enrolled in the previous season XL Stallion Bonus & Incentive will be allowed to compete for this incentive fund.

OUR PLEDGE TO YOU: XL Enterprises, LLC will withhold absolutely nothing from \$1000 Banner Sponsorship until there are a minimum of 25 enrolled stallions. Once a minimum enrollment of 25 stallions has been attained, XL Enterprises, LLC will retain 30% for Advertising & Administration (using this format for calculation: \$1000 - \$200 Stallion Bonus = \$800 x 70% = \$560 per stallion to Incentive Fund / \$240 to XL Enterprises, LLC for Advertising & Administration after 25 stallions are enrolled). So at 25 Stallions the purse will begin to exceed the \$10,000 minimum, by jumping immediately to \$14,000 and then increasing according to the number of enrolled stallions. Should the number of stallions enrolled exceed 50, XL Enterprises, LLC will then offer Stallion Bonus money and Incentive Fund purses at both the Silver and Gold Cup Barrel Futurity and possibly other futurity events. Should the number of stallions enrolled exceed 75, XL Enterprises, LLC will then produce a fall futurity, named the XL Exclusive Barrel Futurity (to be held in conjunction with the Diamond Classic Team Roping Futurity), for which only the progeny of those enrolled stallions will be eligible to compete.

Each stallion enrolled in the XL Stallion Bonus & Incentive Program will receive arena signage during the 2007 XL Enterprises events (Silver & Gold Cup Barrel Futurities and Diamond Classic Team Roping Futurity and any other events produced solely by XL Enterprises, LLC) with one banner hung in each competition arena. Limit one stallion per banner. (See attached conditions for information on the 2007 Bonus and the 2008 Incentive portion of this enrollment.)

This application for stallion enrollment does not constitute a contract until accepted by XL Enterprises, LLC. We agree that XL Enterprises, LLC may either accept or reject this application and return the enrollment payment to the undersigned, thereby discharging any responsibility. We understand our enrollment is non-refundable and non-transferable.

We understand the Show Management will make all decisions for banner space placement during these events. Our banners will remain intact until scheduled hour of conclusion of show, as established by the Show Management.

We agree to abide by the Rules & Conditions to be established by management governing the show.

We understand and agree that XL Enterprises, LLC and the host venues are expressly released and discharged from any and all liabilities, loss, injury or damage to either persons or property that may be sustained on or about the premises or in connection with our enrollment.
